

The **Certified Accounting Technologist** is a new profession that sits between the traditional Accounting Technician and the fully qualified accountant.

You will work at the intersection of modern finance, information systems and organisational governance, leveraging knowledge and expertise developed in the areas of:

- Financial and sustainability reporting.
- Data management & analytics.
- Corporate finance.
- Business intelligence.
- Performance management.
- Decision support & executive corporate governance.

Industry, private accountancy practice, and the public sector. The qualification is designed to reflect emerging trends in the profession, including sustainability accounting and the integration of AI technologies.

Future-Ready Pathway

Certified Accounting Technologist

Business environments are changing due to significant technological, social, environmental, and regulatory developments. ATI recognises the significance of these ongoing changes for accounting professionals and, in response, has developed a new professional role based on focused expertise in accounting, information systems, and organisational governance. The accounting professional for the 21st century is the 'Certified Accounting Technologist'.

The new Certified Accounting Technologist professional builds on core accounting and taxation competencies to develop increasingly in-demand capabilities; such as data analytics and sustainability reporting.

Course Duration

2 Years.

Who can apply?

- Graduates of ATI's Accounting Technician programme or equivalent.
- Qualified or part-qualified accountants.
- Individuals with a business-related qualification that includes foundational accounting and taxation.

Fees

An employer contribution fee of €2,250 will apply annually.

Qualification

BSc Hons in Accounting Technology (Level 8), validated by Technological University of the Shannon.

A new path to career success

The Certified Accounting Technologist will work at the intersection of modern finance, information systems, organisational governance, financial and sustainability reporting.

Programme Structure

The Certified Accounting Technologist will be equipped to enhance financial, social, and environmental value within organisations. They will also possess the skills necessary to facilitate transitions to digital and sustainable economic models.

- The apprentices will undergo a comprehensive two-year, work-based learning programme, with mentorship.
- Apprentices will spend four days per week working with a registered employer (on-the-job) and one day attending classes online (off-the-job).
- It is a degree-level modular standards-based programme spanning two years, combining onthe-job training and off-the-job education.
- Apprentices are paid by their employer, and their college tuition is funded by the Higher Education Authority (in ROI) and Department for the Economy (in NI).

Upon successful completion of the programme, apprentices are awarded a BSc (Hons) in Accounting Technology. Graduates who meet all relevant criteria may then apply to ATI for permission to use the 'Certified Accounting Technologist' (CIATI) designation—a professional credential that recognises advanced capability in accounting, information systems, governance, and sustainability reporting.

Employer Training Value

The Accounting Technologist Apprenticeship is designed to enhance long-term financial, social, and environmental value, preparing businesses for a sustainable economic model transition.

Accounting Technologist Apprenticeship (ROI)

The Certified Accounting Technologist is a new professional role for future-ready finance leaders. This degree-level programme develops expertise across finance, data analytics, ESG, and governance – providing the capabilities to support digital and sustainable transformation in modern businesses.

Validated by the **Technological University of the Shannon (TUS)** and delivered in partnership
with ATI, this apprenticeship leads to a **Level 8 Bachelor of Science (Honours) in Accounting Technology** and the professional designation **Certified Accounting Technologist (CIATI).**

Why Choose This Programme?

- Earn and learn: Fully funded tuition through the Higher Education Authority, apprentices work 4 days a week and attend college 1 day per week.
- Add real value: Modules are designed to embed academic learning with practical industry application.
- Professional designation: Graduates become eligible to apply for the professional award of CIATI through ATI.
- Future pathways: Progress to Master's programmes or specialist routes in finance, sustainability, or analytics.

Programme Overview

Duration: 2 years.

Format: 4 days per week in employment, 1 day in college (Sept-May each year).

5 days a week in employment (June - August each year).

Award: BSc (Hons) in Accounting Technology (Level 8)

Validated by: Technological University of the Shannon (TUS).

Professional Designation: Certified Accounting Technologist (CIATI), ATI.

Entry Requirements

Applicants must hold one of the following:

- ATI Level 6 Advanced Certificate in Accounting (ROI).
- CCEA Level 5 Diploma in Accounting (NI).
- A Level 6 major award in business/finance (QQI or equivalent) with relevant work experience.
- Part-qualified accountants (e.g., CAI/ACCA.
- CIMA with CAP1 or equivalent).
- Relevant Level 7/8 modules mapped through the TUS RPL process.
- Be employed in a relevant role with an approved ROI-based employer.

Funding

Tuition is funded by the Higher Education Authority.

An annual employer contribution fee of €2,250 applies.

Registered employers will be eligible for an annual SOLAS grant of €2,000 per apprentice.

Accounting Technologist Applicant Information Guide

Programme Structure

The Accounting Technologist
Apprenticeship is delivered over two
academic years, structured to integrate
practical workplace experience with
rigorous academic learning. The
programme is modular, standardsbased, and aligned with industry
requirements.

Study Format

- Apprentices attend online college one day per week with Technological University of the Shannon (TUS).
- They work with their employer for four days per week during the college term.
- During non-teaching periods (outside of term time), apprentices return to five days per week in the workplace.

Academic Calendar

The academic year is divided into three semesters each year: Autumn, Spring, and Summer. Apprentices complete a total of 14 modules, including two substantial work-based industry projects.

Modules Overview

 Each year includes six academic modules and one year-long work-based project.

Assessment Methods

 Assessment is continuous and varied to reflect real-world professional demands. It includes group projects, individual assignments, presentations, practical tests, and online exams.

Entry Requirements - Apprentice

- 1. An ATI NFQ level 6 Advanced Certificate in Accounting or the Level 5 Accounting Technician Diploma on the UK Regulated Qualifications Framework (RQF); or an equivalent qualification at these levels.
- 2. Any major qualification at Level 6 on the Irish National Framework of Qualifications (NFQ); or any qualification at Level 5 on the UK Regulated Qualifications Framework (RQF) or Qualifications Framework for Higher Education (FHEQ) and have the relevant work experience; or an equivalent qualification at these levels.
- 3. Part-qualified accountants (e.g. CAI, ACCA, CIMA) who have successfully completed CAI CAP 1 or corresponding equivalent and have therelevant work experience. Fully qualified accountants can also apply.
- 4. Successful completion of relevant modules at degree (L7/L8) level of a business, finance or accounting related programme, mapped, and agreed by via the TUS RPL process, and offered by a recognised HE Institution. Full degree holders can also apply.

Prospective candidates seeking to undertake the Accounting Technologist Apprenticeship must either hold a position in an accounting or financial role or have secured employment with an employer committed to supporting their apprenticeship journey throughout the two-year period.

Recruitment Phases

Applicant Type

You are a current ATI member who graduated after 2022.

Recruitment Stage

Can apply directly from your Touchpoint account, you can see the Accounting Technologist widget on your homescreen.











Professional Certificate in Data Management for Finance

You first need to complete The Professional Certificate in Data Management, which you will find in your TouchPoint account. This is a short, fully online programme designed to catch up the members who have graduated before the most recent syllabus change and may be unfamiliar with the latest in Financial Data Management

You can apply at the same time for the programme in your Touchpoint account, but you must have completed the Certificate before you start the apprenticeship programme.

Become an up to date ATI member by paying the ATI membership fee. Once the membership fee is up to date you will have access to Touchpoint and be able to apply for the Apprenticeship.

The above steps will apply depending on when you graduated.

You must complete the outstanding work experience requirements.
